

# Texas Success Initiative Assessment (TSIA)

---

The Texas Success Initiative Assessment (TSIA) is part of the Texas Success Initiative enacted by the Texas State Legislature and designed to determine a student's readiness for college-level coursework in the general areas of reading, writing, and mathematics. On January 11, 2021, the Texas Success Initiative Assessment 2.0 (TSIA2) was revised to assess a student's readiness for college-level coursework in English language arts and reading and mathematics. Students are required to complete assessments before enrolling at Texas A&M-Kingsville unless they meet one of the exemptions listed below.

## Passing Scores

Students scoring at or above specific scores are considered "college ready" and eligible to enroll in any entry-level college course (for example, English composition, history, government, or college algebra). Some college level courses require passing scores in more than one area.

### Passing Scores for TSIA for tests taken prior to January 11, 2021

- Mathematics: A minimum score of 350
- Reading: A minimum score of 351
- Writing: A score of 5 on the essay section or a score of 4 on the essay and a minimum score of 340 on the multiple-choice section

### Passing Scores for TSIA2 for tests taken after January 11, 2021

- TSIA2 English Language Arts and Reading (ELAR) College Readiness Classification (CRC) Test: A score in the range of 945-990 on the ELAR CRC Test and a score of at least 5 on the Essay Test or an ELAR CRC Test score below 945 and an ELAR Diagnostic Test score of 5 or 6 and an Essay Test score of 5 or higher.
- Mathematics: A score in the range of 950-990 on the Mathematics CRC Test or a Mathematics CRC Test score below 950 and a Mathematics Diagnostic Test score of 6.

## Exemptions

A student shall be exempt from taking the TSIA or TSIA2 (or portions of the test) if the student meets any of the following:

- ACT composite score of 23 and a minimum of 19 on the English portion exempts students from both the Reading and Writing sections of the TSIA
- ACT composite score of 23 and a minimum of 19 on the Math portion exempts students from the Math section of the TSIA
- SAT (taken before March 2016) minimum score of 1070 combined and a minimum score of 500 on each section
- SAT (taken after March 2016) minimum score of 480 on the evidence-based Reading and Writing (EBRW) assessment and a minimum score of 530 on the Mathematics assessment (no combined score needed)
- STAAR end-of-course (EOC) Algebra II-Level 2 score of 4000 or higher for math or STAAR end-of-course (EOC) English III-Level 2 score of 4000 or higher.
- GED minimum score of 165 on the Mathematical Reasoning subject test shall be exempt for the math section of the TSIA and a GED minimum score of 165 on the Reasoning Through Language Arts (RLA) test shall be exempt from the ELAR section of the TSI.
- HiSET minimum score of 15 on the Mathematics subtest shall be exempt from the math section of the TSIA and a HiSET minimum score of 15 on the Reading subtest and a minimum score of 15 on the Writing subtest, including a minimum score of 4 on the essay, shall be exempt for the ELAR section of the TSIA.
- Passing grade in a College Preparatory course in high school, for example, College Preparatory Mathematics (CPMAT) or English Language Arts (CPELA); the course must be notated on the official high school transcript. Exempt for twenty-four (24) months from the date of high school graduation concerning the content area of the course. The student must enroll in the student's first college-level course in the exempted content area in the student's first year of enrollment in an institution of higher education.
- Advanced Placement (AP) test score of a 3 in English Language and Composition and a test score of a 3 in Calculus or Statistics.
- A student who is serving on active duty as a member of the armed forces of the United States, the Texas National Guard, or as a member of a reserve component of the armed forces of the United States and has been serving for at least three years preceding enrollment. A letter from the commanding officer must be submitted.
- A student who on or after August 1, 1990, was honorably discharged, retired, or released from active duty as a member of the armed forces of the United States or the Texas National Guard or service as a member of a reserve component of the armed forces of the United States (A DD214 form showing honorable discharge status is required and must be submitted to Texas A&M-Kingsville)
- Students who take dual credit or have previous college course work may be eligible for a TSIA exemption depending on the college-level courses completed. An official transcript must be submitted for coursework to be reviewed for exemptions.

- m. A student who has graduated with an associate or baccalaureate degree from an institution of higher education may be eligible for a TSIA exemption. An official transcript must be submitted for coursework to be reviewed for exemptions.
- n. A student who transfers to Texas A&M-Kingsville from a public, private or independent institution of higher education or an accredited out-of-state institution of higher education and who has satisfactorily completed at least three (3) hours of college-level core-related coursework with a grade of "C" or better is exempt in the TSIA component area (reading, writing, and/or math) assigned to the course. An official transcript must be submitted.
